**WEATHER UPDATE:** National Weather Service –

(<u>Meteorologist in charge</u>) - Andy Patrick and/or (<u>Meteorologist</u>) - Roger Erickson Discussed - Tuesday, February 11, 2020/Forecast





- The National Weather Service is monitoring a stationary front that extends from Cameron to Lafayette
- This frontal boundary will move further north this afternoon and tonight
- Wednesday, a cold front will move west to east across our region during the day, producing some showers and thunderstorms
- We are expecting less than an inch of rain area-wide from this system over the next 24 to 36 hours
- Some localized spots could see a couple of inches
- The severe weather threat for Wednesday is a marginal 5% for southeast Texas and western Louisiana, and a slight 15% for south central and parts of central Louisiana
- The primary thunderstorm threats on Wednesday will be isolated tornadoes and damaging winds
- In addition, sea fog will continue to be a problem today and tonight for mariners in coastal lakes and bays, as well as out in the northwestern Gulf of Mexico
- Visibilities will improve behind the cold front late Wednesday

#### Discussed - Wednesday, February 12, 2020/Forecast





- The threat for severe weather is decreasing for today
- There is a marginal 5% risk for severe storms east of a Lake Charles to Alexandria line
- Rain totals today will be less than half an inch for the Beaumont to Lake Charles areas, and between half an inch and in inch for the Alexandria to Lafayette areas
- Low visibilities from dense sea fog in the coastal lakes and bays and coastal waters will improve behind the cold front passage later this afternoon and tonight
